Fingerprint clearances for all adults living in or regularly present in the home.	Estimated \$64-\$128 per person, plus rolling fees charged by the LiveScan facility

ICPC packet preparation and administration for interstate adoptions	\$1,000
File opening fee for taking over case from another provider	\$400
